#### Common Reporting Standard ("CRS") / 《共同匯報標準》(簡稱 CRS) / 《共同汇报标准》(简称 CRS)

To help protect the integrity of tax systems, governments around the world are introducing a new information-gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard ("the CRS"). The Inland Revenue (Amendment) (No. 3) Ordinance 2016 ("the Amendment Ordinance") came into effect on 30 June 2016 and has put in place a legislative framework for Hong Kong to implement the new international standard on Automatic Exchange of Financial Account Information ("AEOI"). Financial institutions in Hong Kong are required to collect their customers' tax residence information and report customer information to IRD, as appropriate. In order to comply with this new requirement from 1 Jan 2017, we are required to obtain certification from all new account opening customers to confirm their tax residency. If you are an individual or sole trader, please complete the Individual Self-Certification Form. If you are an entity (corporations except for sole trader), please complete the Entity Self-Certification Form. You can download the forms and get more information about CRS by visiting Hong Kong IRD website (http://www.ird.gov.hk/eng/tax/dta\_aeoi.htm), or our HSBC website.
